The Gulf Coast Association REALTOR® Hall of Fame honors REALTOR® members who have made an extraordinary and distinguished contribution to the real estate industry and the Association over a period of at least 10 years. Hall of Fame induction is GCAR's highest honor.

#### Method of Selection

- 1. Nomination must be by a member an active member of the Association.
- 2. The Award Selection Committee will consist of five members.
- 3. Using the criteria below as a guideline, selection into the Hall of Fame will be by majority agreement of those members of the committee present at the selection meeting.

### Criteria for Selection

- 1. Nominee must have at least 10 years of continuous service as a member of the Gulf Coast Association of REALTORS®.
- 2. Nominee may be a living or deceased member of the Association.
- 3. Nominee must have contributed significantly to the real estate profession.
- 4. For any past president to be considered for Hall of Fame induction, at least five years must have elapsed since he or she served as the Association president.
- 5. Nominee must have been active in at least two levels of the real estate organization local/state/national) and must be recognized as a leader in the real estate industry in his or her community.
- 6. No more than two inductees may be selected each year.

Please be thorough in completing the application form and providing supporting documentation. It will aid the committee in selecting deserving inductees.
