- All applications must include a copy of the applicant's active Mississippi Real Estate License.
- Applicants who are applying for secondary membership or transferring their membership from another association must include a letter of good standing with their application from their current primary association.
- **All completed applications and required forms should be submitted by email to GCARservices@gcarealtors.com.**

**Note: MLS Service for GCAR is provided by MLS United. To access the MLS and other MLS services, you must also complete an MLS United application and pay applicable service and application fees.**

**Applications submitted after 3:00 pm are not guaranteed same-day access.**

## Important Details to Note- Keep this Page

### Association Dues and Dates

- **December 31st** - Annual dues to National, State, and Local Associations are due by this date of each year.
- **November 1st**- Annual dues invoices are posted and available to be paid online by this date each year.
- If dues are not paid in full by December 31st, a \$100 late fine will be assessed. If dues are not paid by February 1, membership will be terminated, and any unpaid fees and dues will be owed by the Designated Broker.
- Your membership will automatically renew each year resulting in an invoice unless a completed License Status Change Form is sent by your Broker to deactivate your membership before December 31st. Members not deactivated by December 31st will owe the following year's full dues.
- Credit card information is not stored on file at GCAR and we do not process automatic payments.
- All membership dues are **non-refundable**.

### Important Reminders:

- After activating your license with the Mississippi Real Estate Commission, you have 30 days to join the Gulf Coast Association of REALTORS® and pay all dues and/or fees in full.
- If your account is inactive or suspended for 60 days or more, you must pay the \$20 application fee again.
- Per NAR, membership dues will not be prorated if the licensee held REALTOR® membership during the preceding calendar year.
- New Member Orientation must be completed within 90 days of joining. Upcoming training dates are posted to GCAR's public calendar which can be found on [www.gcarealtors.com](http://www.gcarealtors.com). NAR requires that the Code of Ethics must be taken every 3-year cycle to maintain membership.
