"REALTORS® Working Together for the Future" 2026

Identifying and training future leaders is the key to improving our local Association and the Realtor® profession. Through this program leaders will be identified, trained and encouraged to take on leadership roles of every aspect.

10 participants will work together through a training course that combines a networking retreat and several day-long group sessions. The training sessions will include identifying personal behavioral styles, team-building exercises, developing leadership skills, networking opportunities and improving communication skills.

Objectives

- To identify local REALTORS® for leadership roles.
- To train participants by developing leadership skills.
- To motivate participants through increased awareness of issues and challenges affecting the REALTOR® profession and their local Association.

Application Procedure

Applicants for the *Coast Realtors*® *Leadership Program (CRL)* are members of the Gulf Coast Association of REALTORS® interested in future leadership roles with GCAR.

Applications are reviewed and participants are selected by the CRL Trustees, who are members from the Gulf Coast Association of REALTORS® Board of Directors and/or alumni of the CRL program. The number selected is limited to a total of 10.

Each participant is responsible for tuition payment. Tuition for 2026 is \$495 per applicant.

<u>Tuition should be paid online in the GCAR Member Dashboard and is due on December 15 as outlined in the Hold Harmless Acceptance Agreement</u>. The tuition covers the cost for all training sessions, meals, overnight accommodations for the sessions, and instructional materials. Additional costs to the participants will include transportation from home to the meeting.

Application forms should include as much information as possible. However, answers should be limited to the space available.

Selection Criteria

Participation in the Coast REALTORS® Leadership Program is open to REALTOR® members of the Gulf Coast Association of REALTORS®, with a maximum of 10 individuals being selected to participate.

Attendance at all retreats and sessions is mandatory as outlined in the Hold Harmless Acceptance Agreement. Those who fail to attend may be asked to withdraw, with no refund of tuition. A calendar of dates is attached. If dates must be changed due to unforeseen circumstances, GCAR will provide as much notice as possible.
